ARTICLE 7 OF LEGISLATIVE DECREE NR. 286 25 July 1998:

"Anyone who, for any reason, provides accommodation or hosts a foreigner or stateless person, even if a relative or an in-law, or employs them for any reason or transfers to them the ownership or possession of real estate, either rural or urban, located in the territory of the State, is required to give written notice within 48 hours to the local public safety authority. Violations of the provisions in this article are subject to the administrative sanction of a fine ranging from €160 to €1,100."
