Residence permits for **MINOR AGE**

Documents to send:

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Document proving the take in charge of minor children by the social services.

Residence permits for **CUSTODY OF MINOR**

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Act of the competent Authority (e.g. Court) for the “inclusion” of the minor in a community, including a family one, or in a public or private care institution.

Residence permits for **MEDICAL TREATMENTS EX ART. 19 BIS C.2 LETT. D  
(PREGNANCY)**

Documents to send:

- Form 209 completed in all its parts
- Declaration of hospitality and rental contract with host identity document
- Copy of a valid passport (all pages with personal data, visas and stamps);
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Medical certificate issued by a public structure with indication of the presumed time of birth.

In case of renewal, the birth certificate together with the paternity and maternity certificate must be produced.

Residence permit for **MEDICAL TREATMENTS EX ART. 19 BIS C.2 LETT. D-BIS T.U.I.**

Documents to send:

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document;
- Copy of a valid passport (all pages with personal data, visas and stamps);
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Certificate issued by a public structure, in compliance with the regulations.

Residence permits for **MISSION**

Documents to send:

- Form 209 completed in all its parts;
- Rental contract;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of a valid passport (all pages with personal data, visas and stamps) of any minor children to be included in the residence permit or other documents useful for identification;
- Service certificate of the family member's mission and date of end of mission
- Copy of residence permit already in the possession of the applicant (expired or currently valid).

Residence permits for **REASONS OF JUSTICE**

- Act of the Judicial Authority requesting release or renewal of the residence permit.

Residence permits for **SERIOUS LABOR EXPLOITATION PURSUANT TO ART. 22 OF T.U.I.**

Documents to send:

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document or title deed to the property;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Favorable opinion of the Public Prosecutor on the issue of the residence permit.

For **RENEWAL** of the residence permit, documents to send:

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document or title deed to the property;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Favorable opinion of the Public Prosecutor on the renewal of the residence permit.

Residence permits for **SOCIAL PROTECTION TO ART. 18 T.U.I.**

Documents to send:

- Form 209 completed in all its parts;
- Declaration of hospitality and rental contract with host identity document;
- Copy of a valid passport (all pages with personal data, visas and stamps) or other documents useful for identification;
- Copy of residence permit already in the possession of the applicant (expired or currently valid);
- Proposal for the issuance of this residence permit by the Public Prosecutor or by the Social Services (with a favorable opinion from the Public Prosecutor) who have detected situations of violence or serious exploitation against the applicant;
- Social assistance and integration program relating to the applicant
- Declaration by the applicant to undertake to adhere to and comply with the aforementioned program;
- Declaration of acceptance of the commitments connected to the program by the manager of the structure where the program is to be implemented;
- Copy of the identity document of the host facility manager;
